Message from the Chair



The AFSRB Office renewed over 700 funeral professionals and 179 funeral businesses for the 2022-23 year. The Board is considering making changes to the reporting of continuing education, and is looking for feedback from the profession. Look for the survey, later in the newsletter. The AFSRB will also be making a change to our website and online business and individual employee portals. Information about this change will be sent out to licensees when available.

The AFSRB guided Legislative Review Committee (LRC) continues to meet and propose changes to our General Regulations which will be submitted to Service Alberta in the next few months. The AFRSB will also be bringing back the Funeral Education Review Committee (FERC) this year to help with upcoming projects.

Changes to The Funeral Benefits Program came into effect April 1st, 2022. At an in-person meeting with AFSA, our Board was told ASFA will be advocating for changes to how this program is currently being run.

Now that in-person meetings have started up again, Del August will be out doing business inspections. Businesses must be inspected by the AFRSB once every 3 years, so if you haven't had an inspection in a year or so look for Del to possibly pay your business a visit.

We had on open industry seat on our board for this coming year and with an industry election held, we would like to congratulate and welcome Stu Murray to the Alberta Funeral Service Regulatory Board for a 3 year term. With Stu coming on to the board, we say goodbye to Dean Ross, as his 3-year term comes to an end. We would also like to thank Dean for his service, insight, and efforts over the past 3 years. Dean led the redesign of the 'Funeral Planning in Alberta' brochure and once it meets board approval it will be available from the AFSRB office.

This newsletter continues to keep funeral professionals in the province updated with current Legislative and Regulation changes, as well as situations that can affect the day-to-day operations of funeral service. Renewals are done for another year! It was the first year we utilized an online system for entering continuing education. FILIS is now open for the new reporting cycle. Lunch & Learn

The AFSRB will be launching a number of "Lunch and Learn" sessions starting in the fall. These will be in a webinar format through Zoom. Sessions may be provided by guest speakers, the AFSRB members or Board staff depending on the topic. Many of these sessions will be based on the feedback the AFSRB received through the mandatory course survey. Each session will be approximately an hour long, with information being provided with some time for questions at the end of the session. Survey Results

Thank-you to everyone who submitted the feedback survey after the completion of the AFSRB mandatory course '*The 5Rs of Funeral Service in the Age of Cremation*'. 278 surveys were submitted and the results have been compiled. As an overall summary, every question had 80%+ positive feedback (strongly agree and agree). Click here for a detailed summary of the results.

There was also written feedback submitted on two topics. One question requested feedback for future topics for the mandatory course, and the other requested feedback on additional information related to cremation that individuals were interested in obtaining. There was a significant variety of responses from these two questions. The Board has reviewed all of this feedback and we now have a number of topics to consider for future sessions.

Do You Have a Student Working at Your Business?

Only individuals possessing a <u>current</u> Eligibility Certificate, issued by the AFSRB, are permitted to engage in activities restricted to licensed individuals or trainees under supervision, <u>and</u>, are eligible to write the Funeral Director exam. Logged activities for the purpose of training and credentialing can only be completed by individuals with a current Eligibility Certificate. To become registered as a student in Alberta, individuals must fulfill the following requirements:

- Step 1: Register in a funeral service education program (funeral director/embalmer)

 Mount Royal University or the Canadian College of Funeral Service.
- Step 2: Be working at a funeral business
- **Step 3: Apply for Student Certificate**

The Business Manager must apply and pay for the registration through FILIS (3.a). A current criminal record check (conducted within the last 90 days), and Student Eligibility Declaration are also required. The declaration can be found on the AFSRB website under the Industry tab.

Note: the initial payment for student certification is only required once, as long as they continue to work at the same funeral business. Students are not included in renewals.

New AFSRB Website

The AFSRB is revitalizing the website and we are asking for your help! The new website will be a source of up-to-date information on funeral services in Alberta and the Board is looking to include imagery related to the funeral profession. The AFSRB is asking the Alberta funeral community to submit pictures you would like to share with the AFSRB for use on the website.

The criteria is as follows:

- High quality pictures of funeral services or cemeteries
- Pictures that you have the rights to, we cannot use pictures that may be copyright (professional photographers, newspaper pictures, etc.)
- Pictures should not depict specific business names, recognizable individuals (without their permission) or names on headstones.
- Historic pictures are also welcome, even if the quality is not perfect

Funeral Education Review Committee (FERC)

The AFSRB is pleased to announce that FERC will be starting some new projects for the Board. A new committee has been convened with the following members: Stuart Murray (AFSRB industry member), Deborah Gust (AFSRB public member), Gemma Beierback (facilitator and former AFSRB public member), and from the funeral profession, Dean Ross, Dale Wright, Sheila Bartsch, Tyler Weber and Chris Jong. The first organizational meeting was held June 8.

The projects that FERC will be undertaking are related to education and training that will be provided by the AFSRB. There are a variety of initiatives that the FERC members will be starting work on in September.

The proposed projects are as follows:

- Course for business managers
- Course for non-professional business owners
- Training for businesses that sponsor students
- Develop a policy for practicum requirements for funeral education students
- Develop introductory information for people considering entering the funeral profession.

The AFSRB will keep you updated on the progress of these projects in future newsletters.

Alberta Insurance Council Renewal Update

The Alberta *Insurance Act* (the "Act") requires that every business that acts as an insurance agent must hold a valid certificate of authority. The Act also requires that a business that is issued a certificate of authority must appoint a Designated Individual ("DI") who is responsible for receiving all notices and documents from the Alberta Insurance Council ("AIC").

This requirement applies to **Funeral Services Businesses** which sell life insurance and annuity products as a way of funding pre-arranged funeral services contracts (i.e. "Funeral Services Insurance"). If you require additional information on licensing please contact the Alberta Insurance Council at licensing@abcouncil.ab.ca

If your **Funeral Services Business** currently holds a valid certificate to sell funeral services insurance, <u>your license(s)</u> will expire on June 30, 2022 and must be renewed prior to that date if you wish to continue doing business. The AIC will email renewal notifications to all license holders through their Designated Individual(s) **in early May**.

If you are not the Designated Individual ("DI") for the license issued to your business, a new DI must be appointed. The new individual must register for their own CIPR number. CIPR numbers are not interchangeable. The new prospective DI can submit an online application by logging into the AIC portal. If the agency name under which you conduct insurance business or the sponsoring insurance company has also changed, the DI must update those changes through an online application. These updates cannot be made on renewal application(s). It is your responsibility to ensure that the agency and DI information provided to the AIC is current and accurate.

Third Party Sellers on Funeral Business Websites

The Board is sharing this information proactively to ensure that the funeral profession was aware of what has occurred in other provinces.

In October there was a CBC Go Public article out of Toronto, where a third-party marketer (through the website platform) was placing advertising on the obituary page of the funeral services business' website, that would lead mourners to a different for-profit site where trees could be planted, candles lit, etc. The family was concerned that the wishes of their loved one (money to be donated for a certain purpose) were diverted to this for-profit site without their knowledge or permission. The mourners who visited the site would not necessarily understand that this was not the wishes of the family and therefore made donations to this third-party site. Mourners may not understand "who" they are donating to because that disclosure was not provided through the website. This article highlights why the possibility of additional sales components must be disclosed to the person making the funeral arrangements if this kind of third-party involvement is part of your website provider's services. If you become aware of this type of activity please notify the Board.
