Legislative Review Committee (LRC)

The LRC is continuing its work on reviewing the Funeral Services Act and Regulations for potential amendments. This committee is also meeting with Service Alberta in regard to the Alberta Government's Red Tape Reduction initiative which looks at streamlining the provisions of the legislation. The timing for completing the legislative review is estimated to be spring 2022. The recommendations will then be finalized by the AFSRB and sent to the Minister of Service Alberta. Continuing Education

Please note: the 'course relevance' section doesn't have to be lengthy, a brief explanation of the relevance to your day to day work is sufficient. If you have not yet set up your Employee Portal to enter your continuing education, please contact the office and we can assist you.

Funeral Benefits for AISH, Income Support recipients & Albertans With Low Incomes

The Government of Alberta works with Alberta's funeral service providers to help make sure Albertans with low incomes and their loved ones can access funeral services and are treated with dignity. Funeral service providers offer an immensely valuable service to vulnerable Albertans and the government remains committed to helping low-income Albertans with the cost of funerals so they can honor their loved ones.

On April 1, 2022, the province will amend how funeral benefits are provided to Assured Income for the Severely Handicapped (AISH) and Income Support recipients, as well as other Albertans with low-incomes. These amendments mean funds will be provided directly to individuals so they can select a funeral provider of their choice and negotiate their own services. The upcoming changes are intended to streamline the complex administrative payment process for clients, families, and service providers and provide people with more choice.

The requirements for who qualifies for funeral benefits is not changing. The family, guardian, or loved ones of the deceased will be able to choose their preferred service provider and have a greater variety of options than the services provided under the current contract and fee schedule.

Community and Social Services staff are working closely with funeral provider associations and the provincial regulator to develop new processes and ensure a smooth transition on April 1, 2022. Funeral service providers will receive written notification from the Government of Alberta regarding the termination of the current contract in late December.

The current process for issuing funeral benefits will remain in place until March 31, 2022. On April 1, 2022 a contract will no longer be required to deliver funeral services to Albertans who are eligible for funeral benefits.

Community and Social Services staff will continue to work with and share information with funeral service provider associations to ensure their members are prepared for the upcoming changes. The department will develop materials for clients and service providers to help navigate the new process.

More information about the new process will be provided in January and February. Members should direct questions about these changes to their association.
